Bring your business card and other credentials (liquor license, permits, etc)

Present your Credentials and the vendor form at the front gate to get your free pass into the event site.

Every booth worker will be required to have a copy of this form

Once in the event site, come to the MOROC media Trailer to get your vendor wristbands and location for your booth.

You are required to conduct your business in a legal manner.

Do you have all the necessary permits required by the city/county of that event?

Do you have your liquor license?

If your selling beer, you are required to check ID's, provide the necessary wrist bands or stamps for your customers.

I agree to pay MOROC for the booth space. I realize that 100% of the vendor fee will be paid out to the drivers.

Each vendor is allowed up to six workers to man their booths. These six workers will not have to pay to enter the event site, but they are required to actually do the work.
